





ENFORCEMENT



Constitutional enforcement is achieved
when bad laws are eradicated via the
practice of jury nullification of law.


United States Constitution - Article Six

The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.

Ninth Amendment of the Bill of Rights

The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.

Tenth Amendment of the Bill of Rights

states:

"The general misconception is that any statute passed by legislators bearing the appearance of law constitutes the law of the land. The U.S. Constitution is the supreme law of the land, and any statute, to be valid, must be in agreement. It is impossible for both the Constitution and a law violating it to be valid; one must prevail. This is succinctly stated as follows:

"The general rule is that an unconstitutional statute, though having the form and name of law, is in reality no law, but is wholly void, and ineffective for any purpose; since unconstitutionality dates from the time of its enactment, and not merely from the date of the decision so branding it. An unconstitutional law, in legal contemplation, is as inoperative as if it had never been passed. Such a statute leaves the question that it purports to settle just as it would be had the statute not been enacted."

"Since an unconstitutional law is void, the general principles follow that it imposes no duties, confers no right, creates no office, bestows no power or authority on anyone, affords no protection, and justifies no acts performed under it..."

"A void act cannot be legally consistent with a valid one. An unconstitutional law cannot operate to supersede any existing valid law. Indeed, insofar as a statute runs counter to the fundamental law of the land, it is superseded thereby."

"No one is bound to obey an unconstitutional law and no courts are bound to enforce it."



6. The establishment of a legal arm.

*To develop a legal battlefield,
both offensively and defensively.*

Establishment of the Legal Arm

Offensive Tactics

- Timely lawsuits filed against offending parties and individuals.
- Ethics complaints and procedures pursued in suitable situations.
- Writs of mandamus
- Challenging the constitutional legitimacy of certain and specific laws, regulations, and procedures.

Defensive Tactics

- Preparations to vigorously defend those who are targets of selective prosecution.
- Effort to introduce fully informed jury legislation.
- Ballot initiatives and referenda to curtail the exercise of corrupt and illicit power.


